## GIFT AID

If you are a UK taxpayer, Gift Aid allows GCG to claim back tax from the Inland Revenue. It costs you nothing, but GCG recovers £5 on each £20.00 subscription. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that GCG reclaims on your subscription in the tax year (currently 25p for each £1 you pay). You can cancel this declaration at any time by notifying GCG.

If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that GCG reclaims, you can cancel your declaration.
